GERMOCID ENZIMATICO is also effective on dry residues and on persistent dirt. It can be used on glassware, plastic and metal, probes, optical fibers instruments, equipment for anesthesia, inhalant therapy, hemodialysis, endoscopy and urology.



GERMOCID ENZIMATICO can also be used in ultrasound equipment.

#### APPLICATION

Enzyme-based detergent for invasive surgical/dental instruments.

#### **INSTRUCTIONS FOR USE**

Dilute GERMOCID ENZIMATICO in a proportion of 0,6-10 % in one liter of tap water, possibly warm, and mix thoroughly.

Before dipping the instruments in the prepared solution, it is advised to decontaminate them with a specific product and rinse with cold water, then dip them in the solution of GERMOCID ENZIMATICO for 10 minutes; in presence of dry residues or persistent dirt extend immersion time to 1 hour, and if necessary use a brush. Complete the processes with a series of rinses, the last one with sterile water.
